No lot or lots shall be removed from the sale premises until paid for and a pass-out slip obtained from the Auctioneer's clerk, but each and every lot shall immediately at the fall of the hammer be considered as delivered, and remain in every respect at the absolute risk of the respective purchaser or purchasers thereof, and shall be removed from the Sale premises at the purchaser's expense. Loading shall be the duty and responsibility of the purchaser.

The purchaser to give his name and dwelling place, and to remove the stock immediately after the sale.

NB All purchasers are hereby notified that all removals shall be supervised by the auctioneers and/or vendors and that in regard to the method and timing of removals the auctioneers and/or vendors directions must be adhered to and shall be final and binding on all parties.
